5). New Clause shall hereby be inserted under Clause III, after Sub Clause (g), of the Original Deed.

Sub Clause h) The Benefits of the Trust shall be open to all irrespective of Caste, Creed or Religion.

New Clause shall hereby be inserted under Clause VI, after Sub Clause (h), to the Original Deed.

Sub clause (i) BORROWING POWERS :

a). To borrow against the security of the assets of the trust by way of bank overdrafts, loan / funds from banks / lending institutions, trust agencies both in India and abroad as prescribed under the statutory provisions for the benefit of the trust and for more effectively carrying out the objects of the trust. The trustees hereby authorize the president for such borrowing and execute such documents, deeds, papers etc., as may be necessary in connection their with.

b) The trust may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, associations, institution or trust for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their



other charitable or public institutions having allied and similar objects on such terms as they think fit and may manage such institutions.

6). **Other New Clauses shall hereby be added as:**
Clause XIV - INVESTMENTS :

a). The funds of the Trust shall be invested in the modes-specified under the provisions of Section 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961, as amended from time to time or any other provisions of the Said Act, which are not specifically incorporated under this Trust Deed.

b). The Powers of the Trustees shall be so exercised to ensure that the income of the Trust would be exempted under Section 11 of the Income Tax Act, 1961, as read with Section 12 and 12-A amended from time to time under the said Act.

c). It is clarified that the power of investment of the Trust Funds including those mentioned in above clauses shall be exercised in accordance with the provisions of Section 13 of the Income Tax Act, 1961. In general and in particular shall not violate the provisions of Section 13(1)(d) read with section 13(5) of the Act, so as to ensure exemption under the Act.


7). **Clause XV - ACCOUNTS :** There shall be maintained all accounts of the TRUST regularly. The accounts shall be duly audited by a qualified Chartered Accountant every year. The account year shall be 1st of April to 31st March of each year.

8). **Clause XVI :** The TRUST formed shall be irrevocable.

9). **Clause XVII :** The Funds of the Trust and the income of the Trust shall be solely utilized, for achievement of the objects of the Trust and no payment shall be made to the Trustee by way of profit, interest and dividend etc.

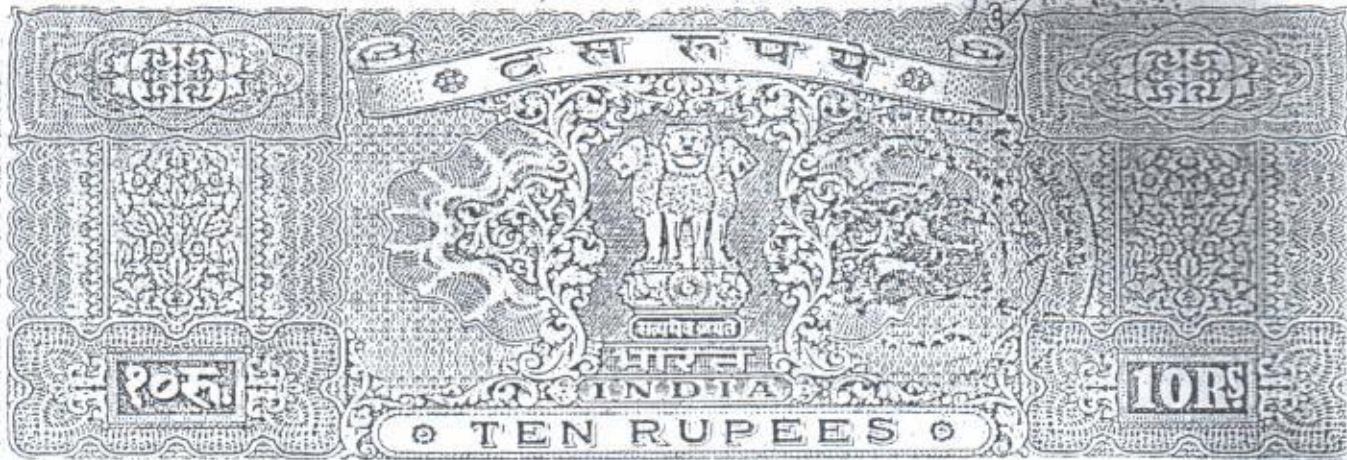

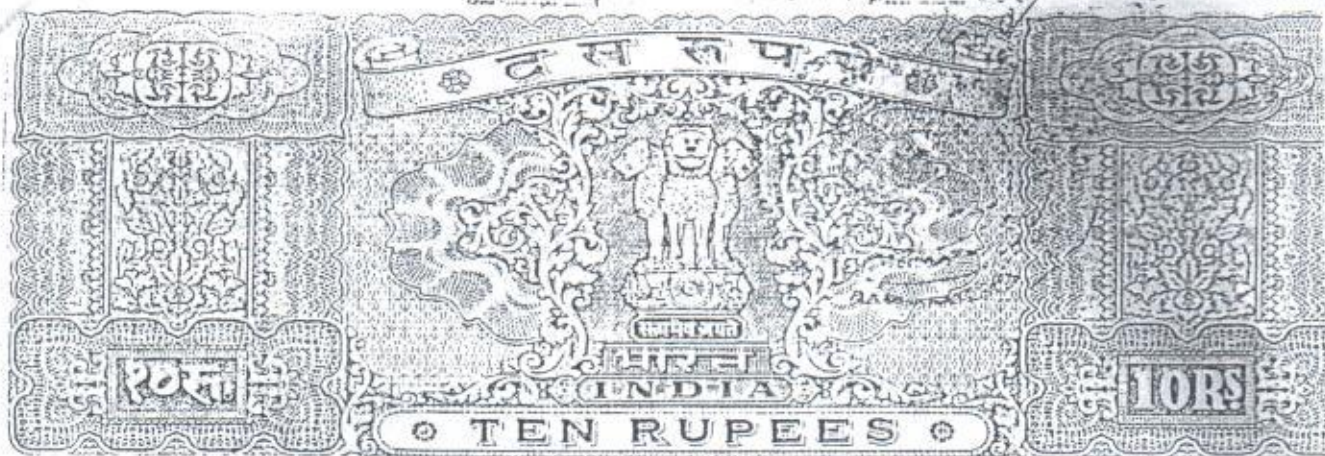

IV. FUNDS OF THE TRUST:

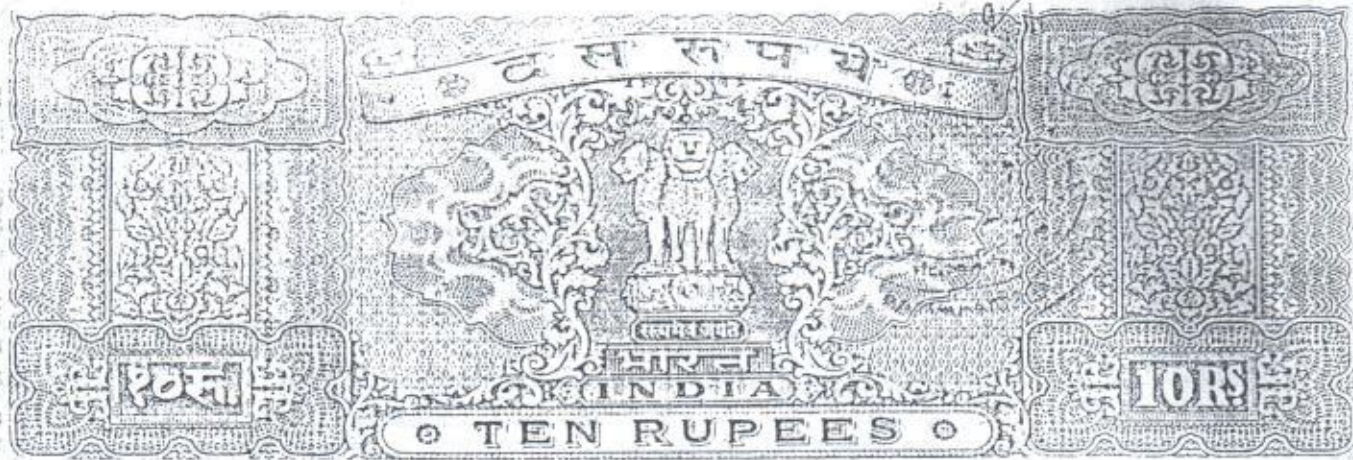

c) Treasurer:- The Treasurer shall receive and disburse all the monies of the Trust and maintain or cause to be maintained the proper accounts of the same. All donations and subscriptions shall be paid to the Treasurer whose receipt, bill be valid and binding the Trust.
